1. Whether you are a new applicant or completing a renewal, signing in to our online Access to Business service (www.accessns.ca/business/login) is required. If you have not created an Access To Business account, select 'Sign up for Access to Business' and follow the steps provided. If you have an existing account, please log in with your Access to Business username and password.
2. **Renewals:** Log in to Access to Business and enter your PIN # and go through the PIN renewal process. Complete the renewal form and 'Add to Cart'. Go to 'My Cart' to complete the payment process. You will be able to pay for your renewal online using Visa, MasterCard or American Express.
3. **New Applicants:**
 - Log in to Access to Business and click on the 'BizPal' link on the homepage.
 - Click 'Search by keyword', type in your municipality and enter 'Farm Registration' as your business search and click 'continue'.
 - Next to the Farm Registration search result, click on 'Add to Briefcase' and then 'View Briefcase'. Open and complete the Farm Registration application form.
 - Once you have completed the form, click on 'Add To Cart'. Go to 'My Cart' to complete the payment process. You will be able to pay for your application online using Visa, MasterCard or American Express.
