Currently, the Nova Scotia Federation of Agriculture represents the interests of over 90% of all agricultural production in the province, while supporting farm families and businesses through lobby and advocacy efforts and the delivery of various programs that support the sustainability of the industry.

The NSFA monitors and reviews trends, legislation, and programs that impact the industry. We actively lobby and advocate for changes and improvements to legislation, programs, and public policy.

Alongside our advocacy and lobbying work, the NSFA is home to a variety of programs that help our farms continue on the path towards a sustainable future. This includes; Farm and Workforce Development, Farm Safety Nova Scotia, Meet Your Farmer, Environmental Farm Plan, Living Labs, and Species at Risk.

In addition to the work we do to further our industry, the Federation also provides benefits to its members. You can find our benefit partners on pages 3-4.

To become a member of the NSFA, you must "Check the Box" on Section 6 of your farm registration form – you will find this on the second last page of the form. There is no additional cost to becoming a member above your farm registration fee.

As your Federation of Agriculture, we are here to support you!

Why should you be a member of the NSFA?

A Trusted Voice: The NSFA has been the voice of Nova Scotia farmers since 1895. Representing the interests of over 90% of all agricultural production across the province.

Accountable Representation: NSFA Council members are elected directly from NSFA membership at the Annual General Meeting. The NSFA works closely with County Federations and commodity organizations.

Strong Committees: The NSFA is home to a number of committees that help influence and guide the work of the

Message from the Executive Director

The winter months are often spent on the road attending meetings and industry events. Stakeholder relations are key to the work we do here at the Federation. We make efforts to attend commodity annual meetings, which gives us a chance to hear about the challenges and opportunities facing each sector. We also hosted our Commodity Roundtable that brings together commodity and affiliate organizations with the NSFA to discuss areas of common interest and to find opportunities to work together. We are currently prioritizing government relations and are hopeful to have the opportunity to meet with government officials in the coming months to bring forward recommendations on how government can support a prosperous and sustainable future.

Speaking of government relations, we have also had a number of government relations engagements both provincially and federally. While Hurricane Fiona sometimes feels like it was long ago, the support farmers need is still very much top of mind for us. As an organization, we were very pleased with the response from the Federal and Provincial governments immediately following the hurricane - it appeared to be very clear they would be here to support the industry recovery. The one-intake application managed by the Nova Scotia Department of Agriculture has greatly minimized farmers' administrative burden. With case managers assigned to each file, it ensures farmers aren't missing out on any support opportunities. However, we are concerned that Federal Programs - AgriRecovery and ACOA Hurricane Recovery Fund – have not been finalized for Atlantic Canadian farmers. The NSFA submitted a letter and met with Minister Bibeau in early February, voicing concerns about the time that has passed and emphasized that it is essential that Federal funding roll eminently. This letter was followed up by a joint letter with the Atlantic Federations of Agriculture this past week. We will continue to advocate on your behalf for the support you need.

I would be remiss if I didn't acknowledge the impact the significant cold snap had on the grape and fruit industries – significant weather events seem to becoming the norm and we will continue to advocate for responsive risk management programs to address the evolving needs of farmers.

Representatives from Farm Safety Nova Scotia also had the opportunity to meet with Minister Morrow and Minister Comer (Minister Responsible for the Office of Addictions and Mental Health) in mid-February. At this meeting, we presented the We Talk. We Grow. Blueprint for a Mental Health Action Plan for Nova Scotia Farmers. There was a great discussion and we look forward to the opportunity to work together with our partners to bring this plan to life.

We are also expecting details on Sustainable-CAP to be available in the coming month. We are looking forward to the rollout of this policy framework and will be monitoring and reviewing programs to ensure they meet the needs of the industry.

As I wrap up writing, we are heading to Ottawa for the Canadian Federation of Agriculture Annual Meeting. This is always a great time to connect with our provincial and national counterparts and discuss key issues impacting Canada's agriculture industry. We will also be visiting local MPs while we are there to ensure Nova Scotia's farmers are top of mind while they are in Ottawa.

Policy Corner

Agencies, Boards and Commissions Every Spring and Fall the Nova Scotia Government recruits for members to Agencies,

Boards and Commissions. The spring recruitment for 2023 will soon open!

What is an agency, board and commission you ask? These are "boards" that are identified in legislation that the government is required to fill. There are a number of these agencies, boards and commissions - or ABCs - that pertain to agriculture. Nova Scotia Farm Loan Board, Crop and Livestock Insurance Commission and Agricultural Marshland Conservation Commission are examples of ABCs.

There are two types of ABCs – adjudicative and non-adjudicative. If you are interested in applying to an adjudicative ABC, there are two intake deadlines each year. Nonadjudicative boards are open year-round until the vacancies are filled. The biggest difference between adjudicative boards and non-adjudicative boards is responsibility. Adjudicative boards have authority to make decisions; the application for adjudicative boards has a series of questions for applicants to demonstrate ability to make unbiased decisions.

Some of these Boards have positions dedicated to NSFA members. If you are interested in applying to represent NSFA and require a letter of recommendation, please reach out to discuss opportunities.

You're interested in applying to an ABC...now what?

There is an application process on the Nova Scotia government's Executive Council website: https://novascotia.ca/exec_council/ abc/. You will need to set up an account if you haven't applied to an ABC before.

Applications are now open for the following agriculture ABCs. The following ABCs are Adjudicative and have an application deadline in late May.



- Agricultural Marshland Conservation Commission
- Animal Welfare Appeal Board (previously known as Animal Cruelty Appeal Board)
- Crop and Livestock Insurance Arbitration Board
- Farm Practices Board
- Farm Registration Appeal Committee
- Meat Inspection Board
- Natural Products Marketing Council

The following ABCs are non-adjudicative:

- Livestock Health Services Board
- Veterinary Medical Association Council, Nova Scotia
- Atlantic Provinces Harness Racing Commission
- Crop and Livestock Insurance Commission, Nova Scotia
- Farm Loan Board. Nova Scotia
- Livestock Health Services Board

The farmer perspective is important on all of the above ABCs and many of the ABCs in other departments. NSFA offers support to members interested in applying to ABCs. This support can be filling out the application with you, talking through your answers to application question, identifying what experiences and skills should be highlighted in your application, setting up your account and more. If you want to apply to an ABC, please contact the NSFA office and they will help you with your application process.

NSFA Makes Submission to UARB

The provincial government made changes to the Electricity Act and the Renewable Electricity Regulations to make way for larger solar and other electricity projects to come on to the grid. These changes required Nova Scotia Power to submit a Commercial Net-Metering Program for approval to the Utility and Review Board. This program will make way for larger net-metering projects.

Nova Scotia Power made application to the UARB in November for approval of the new Commercial Net Metering Program. UARB will consider this matter in a paper hearing process. NSFA Policy has reviewed the proposed regulations and submitted comments to UARB.

Highlights from the submission includes:

- NSFA is in favor of farms are eligible for 1,000kw projects;
- Remove the significant cost for applicants/farmers on single phase lines to implement projects; and,
- Create a process with less red-tape for farms to receive certificates demonstrating the annual volume of renewable energy created on farm.

Can You Name a Species At Risk?

Managing Farm Landscapes to Support Biodiversity Habitat

As part of the Environmental Farm Plan (EFP) Program, we ask questions about wildlife. These can be related to nuisance issues on the farm (e.g. starlings, deer), but when the conversation shifts to species at risk, the conversation is often "Have you observed any species at risk on your property?" and the answer is "No" or "I'm not sure". "What about barn swallows – do you have those?" Often the answer is "Yes" or "I used to but I don't anymore".

Barn swallows are just one example of the species at risk in the province. They were a common occurrence on Nova Scotia farms a generation ago, but have been declining in numbers for decades. An e-News survey last year identified many nesting locations on farms across the province. Many farmers enjoy having these birds around the farm, but had no idea to the significance of their presence.

Currently, there are 63 different plants and animals on our provincial list ranging from American Martin to Yellow-banded Bumble Bee: https://novascotia.ca/natr/wildlife/species-at-risk/. As a province, and as an industry, we need to ensure we are maintaining and enhancing wildlife habitat on farms to support species at risk conservation and recovery. The 15th Conference of the Parties (COP15) to the United Nations Convention on Biological Diversity was held in Montréal, Quebec in December.

COP15 focused on protecting nature and halting biodiversity loss around the world and participants agreed to a global framework putting nature on a path to recovery by 2050. In a previous report by the United Nations, up to one million species globally could face extinction in the near future due to human influence on the natural world.

Environment and Climate Change Canada (ECCC) initiated the Species at Risk Partnerships on Agricultural Lands (SARPAL) program in 2014. The SARPAL initiative is focused on working with the agricultural community to facilitate recovery of Species at Risk (SAR) on agricultural lands through voluntary stewardship actions related to Critical Habitat for Species at Risk.

The Nova Scotia Federation of Agriculture has been working with Dalhousie University, the Nova Scotia Department of Agriculture, Nova Scotia Department of Natural Resources and Renewables, the Clean Annapolis River Project and Birds Canada on various projects and initiatives to improve habitat for species at risk in Nova Scotia. The Wood Turtle Strides project identified critical habitat and provided incentives to conserve habitat. Over 20 farms signed Conservation or Stewardship Agreements covering over 550 hectares that includes some of the most productive Wood Turtle habitats in the species' range.



Since then, funding has been used to develop factsheets and resources and identify high priority areas for future conservation and on-farm demonstrations of conservation practices. We plan to re-launch the farm biodiversity website: https://www.farmbiodiversity.ca/ this spring and hope that it will be a helpful resource for identifying species at risk and providing resources for their support.

We are also planning a workshop series with Birds Canada later this spring pro-

moting barn swallows and other aerial insectivores - how to identify them, support them and report sightings. More information on the sessions, including dates and locations, will be publicized shortly.

SARPAL funding can also be used to support on-farm initiatives to enhance habitat for species at risk. Whether it's bird boxes and nesting cups, riparian improvements, pollinator strips or fields, using flushing bars or changes to forage management, these and other options could be considered for funding assistance.

The Canadian Forage and Grassland Association (CFGA) is leading a national project with financial support from the Canada Nature Fund to develop province-specific, on-line habitat and biodiversity management tools. Nova Scotia is one of three provinces to participate in the first phase of the project and the NSFA and NS EFP program are supporting the project activities. The tool should be available on-line soon. It will be incorporated into the EFP program, but will be available to anyone interested in habitat conservation on their property.

The Resilient Agriculture Landscape Program (RALP) has also been promoted by the NSDA as a new program under S-CAP funding. The program is part of the Federal 2030 Emissions Reduction plan with the intention to support carbon sequestration, adaptation and address other environmental co-benefits. Although details aren't available yet, this program could provide additional support for biodiversity enhancement initiatives.

Many farms already have existing areas within their farm operation that support biodiversity and provide habitat for a variety of wildlife species. There are many opportunities with current and future funding to continue to conserve critical habitat in our province. Farm & Workforce Development

The Farm and Workforce Development team has hit the ground running in 2023! We continue to work under the 5 themes laid out in our Strategic Plan:

- Connect to Farming
- Prepare Strong Farmers
- Manage Farms and People
- Automate and Innovate
- Grow in Diversity

Our Training and Awareness Coordinator has been hard as work, developing new items for Career Promotion. Our goal is to see agriculture careers respected, actively sought after and eagerly promoted throughout the province. We attend career and job fairs across the province, promoting agriculture careers in general, providing insight on pathways into agriculture and most recently, promoting specific jobs on behalf of our members. Our job bank, NSAgJobs, is actively promoted to those seeking employment in the industry.

www.nsagjobs.ca provides an opportunity for employers to post jobs in the agriculture sector and job seekers to see what's available in one spot. Employers can register and post their own jobs or email posting information to mells@nsfa-fane.ca to be included. The website is updated daily and shared widely with potential employees. When posting a job, be sure to include as much detail as you can and anything unique about your opportunity that might distinguish it from others. Being able to offer accommodations, flexible working hours or benefits will catch the eye of job seekers.

As part of our efforts to provide skills training and education that is relevant, practical and accessible, we have our 2023 Workplace Education courses currently underway. These courses are 40 hours in length and offered to the farming community for free thanks to funding from the Nova Scotia Department of Labour, Skills and Immigration. We have four courses running this winter: Financial Fundamentals Level 1, Proposal Writing, Communication for Supervisors Level 1 and Business Skills. These courses are offered in an online, synchronous format

On our **SkillsPass** marketplace, you'll also find a library of useful courses, training and webinars available at no cost to NSFA members. You can access short, self-paced courses on Computer Literacy, Finance, Human Resources and much more. This platform also hosts the Farm Safety courses, previously accessed through the Farm Safety Nova Scotia website

On SkillsPass, employers can create a private portal to track staff training and ensure employees are well equipped to help their business succeed. Individuals can have their certifications in one place to share easily. Check here for a list of courses available and get started at www. nsfa.skillspass.com

The **Farm Technician** trade is still in need of Journeypersons. In order for Apprentices to start the training process, we need Journeypersons in place to oversee their on-farm training. In lieu of going through the apprenticeship training, you can become a Farm Technician Journeyperson right away if you successfully challenge the exam and you have 5400 hours already in the trade. For example, someone who has 5400 verifiable hours spent as a herdsperson, can challenge the exam and if they pass, gain Journeyperson status. The fees typically associated with this process are waived until November 2023. If you would like to prepare prior to taking the exam, Dalhousie is offering a Refresher Course, open until April 30th. The refresher course is online, selfdirected and should take 90 hours to

complete.

As we continue to encourage solid business practices within farms, we celebrated Farm Transition Appreciation Day On January 10th with book give aways and promotion of our **Succession Planning** resources. We ended the month with a presentation by Elaine Froese on "Finding Fairness in Farm Transition". If you're ready to get started on planning transition and farm succession, make sure you access our online planning tool, www.nsfarmsuccesion.ca.

Striving to be an industry that embraces innovation and automation, we are focused on the promotion of **Continuous** Improvement. Our funded CI Project is starting to wind down with four projects currently in motion. We look forward to sharing the success of these projects and further promoting the benefits of applying continuous improvement practices on-farm.

In Nova Scotia, we are enriched by the diversity of our cultural communities. The **Bridge Into Agriculture** program, an online course offered to African Nova Scotians across the province, is running for a second time this March. Beginning on March 22nd, this program is an introduction to the basics of horticulture, starting from the planning of a garden and guiding participants through planting, maintenance and all the way to harvest.
